

L. H. J. <sup>Liber No. 46</sup> Resolved, That the appointing new officers here with Fees, without the Consent of the People of this Province, or their Delegates in Assembly, is illegal and oppressive

On Motion of a Member, ordered, that the Committee of Laws prepare an Address to the Governor requesting him to order to be laid before this House, Accounts properly authenticated, of the Fourteen Pence Sterling p Tun on all shipping trading to this Province to this Province, and not belonging thereto, and also of the Twelve pence per Hogshead on all Tobacco exported, as collected yearly by the several naval officers

Maj<sup>r</sup> Hall delivers M<sup>r</sup> Speaker a Bill entituled An Act impowering the Vestrymen and Church Wardens of Christ Church parish in Calvert County to build a Chapel of Ease in the said Parish, and to impower the Iustices of said County, to levy on, the Taxable Inhabitants of the said parish, the sum of Eighty Thousand pounds of Tobacco for the uses therein mentioned; which was read the first and second Time by an especial order, passed, and sent to the Upper House by M<sup>r</sup> Brome and M<sup>r</sup> Mackall.

The Bill entituled, An Act for erecting a County school in Worcester County and Appointing Visitors for the same was read the second Time, will Passed, and sent to the Upper House by Col. Henry and Col. Scarborough

M<sup>r</sup> Hammond, from the Committee of Laws delivers M<sup>r</sup> Speaker a Bill entituled, An Act for raising Sterling per Hogshead on all Tobacco to be exported for purchasing Arms and Ammunition for the Defence of this Province; which was read the first Time, and ordered to lie on the Table.
