Sir M<sup>r</sup> Benjamin Scott held a first Lieutenancy in the Maryland line, & served some considerable Time with Credit, but from Indisposition was obliged to Resign his Commission & Leave the Army. He has now recovered his Health and is desireous again of serving his Country Line as for some time entittled to the Command of a Company I will now except of one in the Reg<sup>t</sup> extraordinary to be raised. I am Authorised to say that he is a Gent<sup>n</sup> Who's Conduct & Bravery deserves Your Excellency notice. I also take the Liberty to mention two Other Genn of distinguished merit but who's perticular situation in the Army has heretofore prevented their promotion. Capt<sup>n</sup> Alexander Lawson Smith was appointed early in the beginning of the War to the Command of a Company in a Rifle Regiment: raised between Maryland & Virginia, it being an independent Regiment raised for three years the Officers had no advantage of any Vacancies in the line by which enferior younger Officers have been promoted & Command them, That is gauling to men of feeling & Military Honor,

Capt<sup>n</sup> John Carlile was appoint'd to the Command of a Company in Col<sup>o</sup> Hasens commonly call'd the Congress regiment which is also detatchd from the Line and he has sum Younger Officers promoted above him.

I have allways felt an unwillingness to mention or Recommend any Gent<sup>n</sup> for Appointments, but knowing the merrit of these two I cannot avoid recommending them for perferment in the nine Regiments now to be raised.
