problems that they may request; and assists any commissions or committees that they, or a standing committee of the Legislature, may appoint to study taxation or related questions.

The Bureau's general duties include the study of State agencies, study of State and local taxation, study of State and local financial affairs and fiscal relationships, collection of data on the revenue and expenditures of the State's political subdivisions, and compilation and publication of financial data on the subdivisions. Each county, incorporated city or town, or special taxing district is required to submit a fiscal report to the Bureau annually (Code 1957, Art. 41, secs. 145-52; Art. 19, secs. 35-41).
