BE IT ENACTED, by the General Assembly of Maryland, That Constable to be and from and after the passage of this law the levy court of Montgomery county be and they are hereby authorised and empowered. to appoint a constable annually for the town of Brookville, in Montgomery county.

2. And BE IT ENACTED, That any constable who may or shall To qualify according to law. be appointed under the direction of this act, before he proceeds to act in his office, shall qualify according to the form and manner prescribed by law, and shall give bond, with security, for the faithful performance of his duty, and shall be entitled to the same fees as other constables appointed by law.

CHAP. XXI.

An Act relating to Lunatics, Idiots and Persons insane. Lib. TH. Passed May 29 No. 3, fol. 578.

1. BE IT ENACTED, by the General Assembly of Maryland, That chancellor's power in cases of inthe chancellor shall have full power, on the application of any natices, &c trustee of a lunatic, idiot or person insane, and receiving proof to his satisfaction that it is necessary or proper to confine such lunatic, idiot or person insane, to direct such trustee to send the person under his charge to the hospital in the vicinity of the city of Baltimore, provided he can be there received, to remain until the further order of the court of chancery.
