Persons using water, and negrecting to pay tax, o for feit troble the sum

5. AND BE IT ENACTED, That if any person or persons who may use the said water so introduced as aforesaid, after being notified by the secretary or such other officer of the corporation as they may find it necessary to appoint, shall refuse or neglect, for one month after such notification, to pay the tax or contribution imposed by them, such person or persons so refusing, shall forfeit and pay to the said corporation treble the sum so required, to be recovered as aforesaid; and in all cases of actions or suits, either at law or in equity, brought by said corporation for injuries done to the conduits, pipes, reservoirs or hydrants, laid and erected by virtue of this act, upon verdict found against the person or persons so offending, he, she or they, shall in addition to the damages and costs, incur a fine of twenty dollars, to and for the use of said corporation.

Levy authorised for their support

BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court of Saint Mary's county shall and they are hereby directed and empowered, at their levy court annually, to levy on the assessable property of said county, so long as they shall see cause, for the support and maintenance of Eleanor Wood, Elizabeth Roberson and Margaret Scott, of said county, a sum of money not exceeding thirty dollars each, and the same when collected shall be paid by the collector of said county to them or their order for the purposes aforesaid.

BE IT ENACTED, by the General Assembly of Maryland, That from and after the passage of this act, there shall be allowed to each grand and petit juryman attending Saint-Mary's county court, in addition to the sum now allowed, the sum of one dollar for each and every day such grand and petit juryman shall attend for the discharge of his duty as such, to Le allowed, assessed, and levied, in the same manner as the allowance to jurymen has heretofore been assessed and levied.
