And he it enacted, That the said commissioners be directed not to sell any Certain promore of the property pledged for the redemption of the last emission, except ne- perty not to be fold, &c. groes, stock, and other perishable articles, which they may fell for current money, one third thereof to be paid in three months, one other third in fix months, and the residue in twelve months from the sale, and bond with security shall be taken for payment; and the money arifing from fuch fales, and the bonds given therefor, shall be subject to the future disposal of the general assembly.

An ACT to furnish the southern army with twenty dragoon horses.
