## C H A P.

An ACT for the relief of the poor within the county of Baltimore.

An alms-house is to be built in the said county, and the commissioners of the loan-office are directed

An alms-house is to be built in the said county, and the commissioners of the loan-office are directed to lend the trustees, appointed by this act, the sum of £.4,000, out of that part of the bills to be emitted, which are appropriated for loan to the inhabitants of that county.

Every inhabitant of that part of the county, which, after the division, shall retain the name of Baltimore, shall, in the year 1774, and every year afterwards, pay the sheriss 12lb of tobacco, or 1/6 in money. The sheriss is to collect the same, as he does the county levy; and, after deducting his commission, shall, by the 31st of August, pay to the commissioners the whole amount of the tax, in money, rating the same at 12/6 per hundred. And, in case of failure on his part, they are to proceed against him, and his securities, on his office bond, in the same manner as they are directed to do on bonds given for loans; and they shall recover likewise an interest of sour per cent. When payments are made to them, they shall give the county credit; and, after they shall have received the whole principal and interest on the money by them advanced, they are to give notice to the sheriss, and the tax of 12 per poll is to cease.

If any part of this 12 per poll tax be paid in tobacco, the sheriff is directed to sell it in open court, on the fecond day of the August term following. In his account with the court, he shall be allowed annually for infolvents, as well as for those who pay in tobacco; and he shall be charged with the price for which the tobacco shall have been fold. At November term, after his last collection, he shall account for any to the payor the firmly of the town payor the firmly of the town payor the firmly of the town payor. count for, and pay to the court, the surplus of the tax, remaining, after the payment of the said principal and interest to the loan-office.

The refidue of this act is, as nearly as may be, a copy of the general law of 1768, ch. 29. So that the poor-house of Baltimore county is upon the same footing, as if Baltimore county had been comprehended

within that law.

### C H A P. XXXI.

C H A P. XXXII.

An ACT to enable the undertaker for building the stadt-house to cover the same with copper.

The fladt-house is directed to be covered with copper, of such thickness as that a foot square shall contain 180z. 4 dwts. at least, instead of the slate, lead, or tile, already contracted for. The undertaker is required to fix, in the best manner, an iron rod, pointed with gold or silver, to reach six seet above the cupola, and to run six seet below the surface of the ground. The commissioners of the loan-office are directed to pay him £. 1,455 2 8 sterling, as a full satisfaction for doing what is herein enjoined, upon his giving security in double the sum for refunding it, with interest of sour per cent. In case the said cover be not on in a complete and workman-like manner, by the feet day of lines now. not put on, in a complete and workman-like manner, by the first day of June next.

## C H A P. XXXIII. An ACT for payment of the public creditors.

The journal of accounts, passed this session, is to be discharged by the commissioners of the loan-office, with bills of credit, at the rates of  $1\frac{2}{3}$  dollar for 100lb. of tobacco, and one dollar for 756 in money.
