* Of this sum, \$5,416,444.44 is Sterling Debt, on which the interest is payable in London in gold or its equivalent.

† The Sterling Debt being originally calculated at \$4.44 4-9 per £ Sterling, the amount reduced on that basis appears to be \$106,111.11, whereans, being payable in gold, and rated by Article 94, Sec. 13 of the Code, at 4.84 per £, the cost of the same, is \$115,555.00.

For this balance of \$6,625.236.23, the State has as an off-set her unproductive stocks, amounting to \$22,122,441.63 and \$2,200,440.51 due by Accounting Officers and Incorporated Institutions.
