C H A P.

A Further additional supplementary act to an act, entitled, An act Passed 10th of June, 1809. for regulating the mode of staying executions, and repealing the acts of assembly therein mentioned.

BE IT ENACTED, by the General Assembly of Maryland, That from and after the fourth day of July Ad repealed next, the act of the congress of the United States, entitled, An act laying an embargo on all ships and vessels in the ports and harbours of the United States, and the several supplementary acts thereto, so far as they relate to the provisions contained in the acts of the general assembly of Maryland, passed at the last session, chapters nineteen and one hundred and fitteen, being further supplements to the act to which this is a further additional supplementary act, shall be deemed, considered and taken, to be wholly repealed and annulled.

An ACT to alter the thirty-second and thirty-seventh articles of the Passed 10th of constitution and form of government.

BE IT ENACTED, by the General Assembly of Maryland, That hereafter, upon the death, resignation, Legislature not or removal out of this state, of the governor, it shall not be necessary to call a meeting of the tobe called. &c. legislature to fill the vacancy occasioned thereby, but the first named of the council for the time being, shall qualify and act as governor until the next meeting of the general assembly, at which meeting a governor shall be chosen in the manner heretofore appointed and directed.

II. And BE IT ENACTED, That hereafter no governor shall be capable of holding any other office No governor to of profit during the time for which he shall be elected.

· III. And BE IT ENACTED, That so much of the thirty-second and thirty-seventh articles of the Part of articles constitution and form of government as is repugnant to, or inconsistent with, the provisions of this repealed. act, be and the same are hereby abrogated and abolished.
