3rd present Hannah: Holland for having a Bastard Child. Informer. Thomas: Beauchamps. — — —

Lazarus: Maddox forsworn.

For which these Presentments was given in. The Court Ordered process to issue thereon.

3rd present Infamiah: Hazzard for Bastard bearing. Informer James Sangster. — — —

4th present John: Hopworth for relating that he had Laine: wife Sarah: the wife of Thomas: Laine & thereby had made her a Whore. Informer. John: Carter. Evidences for their Malices agt Hopworth are John: Loatz Laine and Sarah: his wife. James: Carter. & Mary: wife of John: Carter.

5th present Honora Cunnor alias Collins for Bastard bearing. Informer Jm: Gray & Jm: Martwill.

Upon Information to the Court that Richard Lugg late Constable of Ammester Hundred was dead. the Court do: Order Adam: Houtte Constable in sd Luggs place. and that he y^e said Houtte be sworn to appear before some Justice of the Peace to take the Oath of a Constable. wth Sum & Cate was sent. —

Samuel: Huswell in Constable of Nantuxet being that day bound to appear, and being called did not appear. The Court Order Summons for sd Huswell to show Cause pra. alias fined. — — —
