served as agent for the state during the Revolution: procured supplies and vessels, superintended the construction and outfitting of vessels for the Maryland navy, arranged for the transport of troops and supplies, was involved in exporting goods from Baltimore Town for the state. LOCAL OFFICES: commissioner to make roads leading to Baltimore Town, appointed 1774; agent to purchase provisions, Baltimore County, appointed 1778; Board of Commissioners, Baltimore County, in office ca. 1781; councilman (first branch), Baltimore City, elected 1797. WEALTH DURING LIFETIME. PERSONAL PROPERTY: store or warehouse on "Hollingsworth's Wharf," Baltimore Town, which burned in 1794. Built a large brick warehouse at the head of his dock before his death. His marriage contract with Rachel Parkins provided that each partner would hold his or her property individually and choose his or her heirs. LAND AT FIRST ELECTION: at least 456 acres in Washington and Anne Arundel counties, plus 16 lots in Baltimore Town (8 owned outright, 5 held by lease, 3 leased out for ground rent). SIGNIFI-CANT CHANGES IN LAND BETWEEN FIRST ELEC-TION AND DEATH: sold his land in Anne Arundel and Washington counties and bought a house and lot in Alexandria, Virginia. During the 1790s he sold or leased out almost all of his lots in Baltimore City, reserving ground rents on at least 4 lots (as well as the leases he already held on 3 others). By the early 1800s he mortgaged or sold additional lots and leases to pay the creditors of his son Zebulon. WEALTH AT DEATH. DIED: will probated on October 6, 1810, in Baltimore City. PERSONAL PROPERTY: included stock in the Bank of Maryland, Bank of Baltimore, Frederick Turnpike Road, Reisterstown and York roads, 2 houses on Calvert Street and 2 houses on East Street, Baltimore City. Requested no appraisal of his estate. LAND: 2 lots in Baltimore City, plus ground rents on 3 more lots in Baltimore City and 1 lot in Baltimore City leased to him; also a house and lot in Alexandria, Virginia.

HOLLYDAY (HOLLIDAY), HENRY (ca. 1725–1789). BORN: on March 9, ca. 1725, at "Wye House," Talbot County; younger son. NATIVE: third generation. RESIDED: in Philadelphia, Pennsylvania, ca. 1739; Queen Anne's County, after 1747; "Ratcliffe Manor," Talbot County, by 1768. FAMILY BACKGROUND. FATHER: James Hollyday (1696–1747), son of Thomas Hollyday (ca. 1661–1702/3). MOTHER: Sarah (1683–1755), widow of Edward Lloyd (1670–1718/19); daughter of Nehemiah Covington (?-ca. 1713), of Somerset County,

and wife Rebecca Denwood. AUNTS: Margery Hollyday Covington (?-1764), who married second, Thomas Gantt (?-1765); Elizabeth Covington, who married Benjamin Wailes (?-ca. 1729); and Priscilla Covington, who married Robert King (1689-1755). BROTHER: James Hollyday (1722-1786). HALF BROTHERS: Philemon Lloyd (1709-1729); Edward Lloyd (1711-1770); James Lloyd (1715-1738); and Richard Lloyd (1717-1786). SISTER: Sarah (1727-1729). HALF SISTER: Rebecca Lloyd (1713-ca. 1776). FIRST COUSINS: Mary King (1715-1739), who married Abraham Barnes (?-ca. 1778); Elizabeth Hollyday, who married Francis Lee (?-1749); and Mary Hollyday, who married Francis Waring (1715-1769). MARRIED on December 9, 1748, Anna Maria (ca. 1732-1804), daughter of George Robins (1697-1742); stepdaughter of William Goldsborough (1709-1760); granddaugher of both Thomas Robins (1672-1721) and Richard Tilghman (1672/73-1738/39); niece of William Tilghman (1711-1782), Edward Tilghman (1713-1786), James Tilghman (1716-1793), Matthew (1717/18–1790), Mary Tilghman Tilghman (1702-1736), who married James Earle, Jr. (ca. 1694-1739), and Anna Maria Tilghman (1709-1763), who married first, William Hemsley (1703-1736), and second, Robert Lloyd (ca. 1712-1770); half niece of Elizabeth Robins (1710-1746), who married William Goldsborough (1709-1760). Her brother was Thomas (1740-1762). Her sisters were Margaret (1734-1808), who married William Hayward (?-1791); Henrietta Maria (1736-1791), who married James Lloyd Chamberlaine (1732-1783); Susanna (1738-?); and Elizabeth (1742-by 1764).
