LOCAL OFFICES: justice, Cecil County, 1689-1697, 1700-1708, 1709-1719/20; North Sassafras Parish Vestry, Cecil County, 1693-1703, 1709-1711; naval officer of Cecil County, 1701-1711 (resigned); deputy commissary, Cecil County, by 1704, in office 1714, 1719; justice, Court of Oyer and Terminer, 1715. STANDS ON PUBLIC/PRIVATE ISSUES: delayed one year before taking oath of office under Protestant Associators' government, 1689. WEALTH DURING LIFE-TIME. LAND AT FIRST ELECTION: at least 1,486 acres in Cecil County (including 1,366 acres his wife received from her father). WEALTH AT DEATH. DIED: will probated June 10, 1729, in Cecil County. PERSONAL PROPERTY: TEV, at least £714.17.4 (including 11 slaves, plate valued at £41.13.0, and gold valued at £20.3.9). LAND: over 2,366 acres in Cecil County.

VANHACK(VANHECK), JOHN (?-1675). BORN: in Virginia, of age by 1660; probably only son. IMMIGRATED: by 1651, as a minor with his mother and stepfather from Virginia. RESIDED: in St. Michael's Hundred, St. Mary's County; in Baltimore (later became Cecil) County by 1668. FAMILY BACKGROUND. FATHER: Oliver Vanhack (1600-by 1645), householder in Elizabeth City County, Virginia, by 1637. STEPFATHER: George Mee (?-1662). MOTHER: Catharine (1601-?). MARRIED Sarah (?-ca. 1677), daughter of Thomas Howell (?-1675) and wife Elizabeth, stepdaughter of Jonathan Sybray (?-1684). Her brothers were John (ca. 1658-ca. 1683); Nathaniel (?-1688). CHIL-DREN. DAUGHTER: Sarah (1676-?), who married ca. 1691/92 Stephen Coleman (?-by ca. 1702) and moved to Philadelphia, Pennsylvania, by ca. 1702. Sarah was involved in a lengthy court case as a result of Coleman's attempt to marry her in 1688. PRIVATE CAREER, EDUCATION: literate. RELIGIOUS

AFFILIATION: Protestant, SOCIAL STATUS AND AC-TIVITIES: Mr., by 1662; Gent., by 1664; naturalized by Act of Assembly in 1669 because he was not of British or Irish descent. OCCUPATIONAL PROFILE: planter; merchant; factor to Peter Devitt, merchant of London, PUBLIC CAREER, LEG-ISLATIVE SERVICE: Lower House, Baltimore County, 1669, 1671-1674 (Laws 3, represented Cecil County after the 3rd session of the 1671-1674/75 Assembly); Cecil County, 1674/75 (elected to the 4th session of the 1671-1674/75 Assembly as a delegate for newly established Cecil County). LOCAL OFFICE: justice, St. Mary's County, 1664-1666, Baltimore County, 1672, Cecil County, 1674-1675. WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: at least 1,550 acres in Baltimore County and possibly 1,100 acres in Somerset County. Vanhack had sold 400 acres in St. Mary's County prior to his move to Baltimore County in 1668. WEALTH AT DEATH. DIED: between November 17 and December 13, 1675, in Cecil County. PER-SONAL PROPERTY: TEV, 71,974 pounds of tobacco (including 4 servants, plate valued at 800 pounds of tobacco, and a boat valued at 1,500 pounds of tobacco); FB, 16,445 pounds of tobacco. LAND: ca. 1,550 acres in Cecil County and possibly 1,100 acres in Somerset County.

VAUGHAN, ROBERT (1597-ca. 1668/69). BORN: in 1597, probably in England. IMMIGRATED: in 1634, as an indentured servant, RESIDED: in St. George's Hundred, St. Mary's County; Kent County, by 1638/39; St. Clement's Hundred, St. Mary's County, in 1640; Kent County, by 1642. MARRIED Mary. She subsequently married second, Thomas Ingram, and third, Jeremy Eaton. CHILDREN. SONS: Thomas (?-1684), who married Susannah (?-1699), probably the daughter of John Beard of Talbot County; Charles (1655-1685); and William (1656–1684). DAUGHTER: Mary, who married first, Edward Burton, and second, James Ringgold (ca. 1637-1686). PRIVATE CAREER. ED-UCATION: literate. RELIGIOUS AFFILIATION: Protestant. SOCIAL STATUS AND ACTIVITIES: arrived as servant to Leonard Calvert (ca. 1606-1647), was free by 1637/38; claimed rights to 50 acres in 1640; Gent., by 1647. OCCUPATIONAL PROFILE: servant, free by 1637/38; planter. PUBLIC CAREER.
