CHAP. LI.

An Act for the relief of Margaret Johns Key.

CHAP. 51.

Be it enacted by the General Assembly of Maryland, Additional title. That Aquilla Beall, and Louis Mackail, of Prince-George's tree exposured to exact execute county, be and they are hereby appointed additional trustees, trusts to execute the trusts created by the last will and testament of Benjamin Mackall, late of George-Town, in the District of Co-Tumbia, in the same full and ample manner as if they had been thereto appointed by the last will of said Mackall, and that they, together with Brooke Mackall and Samuel I. Potts, (the trustees in said will named,) or a majority of them, be and they are hereby authorised and empowered, to sell and convey all or any part of said trust estate, which has already vested, or may hereafter vest in the said trustees, or any of them, as they, or a majority of them, may deem expedient or necessary; and they, or a majority of them, have full power and authority to purchase and have conveyed to them other property, and to complete and perform any contract for the purchase of property heretofore entered into by the trustees appointed by the will aforesaid, to yest and enure to the same trust and uses, as those ereated by the last will and testament of the said Benjamin Mackall.

CHAP. LII.

An Act to after the times of holding the County Courts in Worcester and Passed Feb 2, 1827 Somerset Counties.

1. Be it enacted by the General Assembly of Maryland, courts in World That from and after the passage of this act, the county court of on first Mondays and National Workster county, shall be hadd on the first Monday of May and National May and National State of the Monday of May and National May and May and National May and May Worcester county shall be held on the first Monday of May, vender and the first Monday of November next, and on the same days in each and every year thereafter, and that all causes, pleas, process and proceedings, civil and criminal, now depending in the said county court, or hereafter to be issued therefrom, shall be continued and returnable to the said days respectively.

2. And be it enacted, That from and after the passage of In Somerset, third this act, the county court of Somerset county shall be held on and November the third Monday of May, and the third Monday of November next, and on the same days in each and every year thereafter, and that all causes, pleas, process and proceedings, civil and criminal, now depending in the said county court, or hereafter to be issued therefrom, shall be continued and returnable to the said days respectively.

3. And be it enacted, That all laws heretofore passed, which Repeal directed the county courts of Worcester and Somerset counties, to be held on any other days than those above directed, be and the same are hereby repealed.

CHAP. LIII.

An Act establishing a Library for the use of the Legislature.

1. Be it enacted by the General Assembly of Maryland, Books. &c. be-That all books, maps and public documents, now in possession because parally of the state, or which may hereafter be purchased or obtained, shall be kept separately, and placed in the same room, set apart
