being severally called over by their Names do appear as above and were sworn and charged and sent out to find
soon after the Grand Jurors of the County of Somerset charged and shown Returned hereto and being again
severally called Over by their Names Returned to the Court the following Distincts Against William
Ralph, Diller, John Talbot, Margaret Madder, Randall Long, William Beach, Leah Summers May Noble,
Jonathan Cliff, Nages Peter, Dennis Tinker and John Cooks Thereupon the Grand Jurors of said County and returned
four hundred pounds of value to be levied Next Tuesday next and that Against Randall Long, William Beach
Leah Summers, May Noble and Jonathan Cliff be of said County it is Ordered that Execution be Returnable to August next

faithfully she shall serve his service keep his Commandments Lawfully and honestly every where willing by the Master
and in all things as regard and faithful apprentice she shall demean herself towards her said Master and all his

proper person covenants with the Justices of the same Court in Court judicially thing in manner and form
following that is to say that he the said William Shaw shall and will during the term of years hereto apprentice
hereto and to his heirs and assigns and to Read well in the Bible and at the opinion of his said Master give her
a new suit of clothes of County Make and above her common wearing clothes and likewise find and provide for
his said apprentice meat drink washing Lodging and Clothing sufficient for such an apprentice to have and wear
During the term of years Whereupon the said William Shaw with William Giles and George Bennett of the same
County Planters his security all present herein Court in their proper persons acknowledged themselves bound
unto the said William Shaw with Jemimah Read in Twenty pounds of Money of Maryland on their bodies goods or
chables Lands and Tenements jointly and severally to the use of the said Jemimah Read her heirs and assigns to be
made and levied if it happen that the said William Shaw do not during the term of years hereto apprentice
to his said Master and assigns and Read well in the Bible and at the opinion of her said Master do not give her a new
suit of clothes of County Make and above her common wearing clothes and do not likewise find and provide
provide for his said apprentice meat drink washing Lodging and Clothing sufficient for such an apprentice
to have and wear during the term of years
