 from Ex. } made on the 3^d. day of May 1847, to wit:

Mary J. Kelly, Know all men by these presents that I Mary Jane Kelly of
 Dorchester County in the state of Maryland, for and in
 consideration of the sum of twenty seven dollars and six cents, current
 money, to me in hand paid by Jonah Kelly, of the County and state a-
 foreaid, at and before the sealing and delivery of these presents, the witness
 whom of I, Mary Jane Kelly, do hereby acknowledge, have granted, bar-
 gained and sold, and by these presents do grant, bargain and sell,
 unto the said Jonah Kelly, his Executors, Administrators and Assigns,
 all the goods, household stuff, implements and furniture hereinafter
 particularly mentioned, that is to say, one Bay Mare, one set Pottery,
 one Milk house, five chairs, one Writing Chair, two Sheets, one eating
 Axe, one half Bushel, one Barrel Vinegar, one Harness, Plough & Gear,
 Tin Ware, two trays, one Tin Coffe pot, Cupboard Ware, one Safe, Statuaries,
 a pot, one & hooks, 1pt. Tong & Shore, one Mantle clock, one pair
 Candle Sticks, one Candle Stand, one lot Duns Ware, one set Knives
 and forks, one Bureau, one Pine Table, Tea Board & Caskets, one Trunk,
 one Bed, Stud & furniture, one do Trunk, one do, Stud & furniture,
 one Chest, two Cows, one Plough & gear, one set Wood Ware; all and
 singular which goods & chattels are now remaining, standing and being
 in the possession of me, the said Mary Jane Kelly — To have and to hold
 all and singular the said goods, household stuff and furniture, and other prop-
 ies, above bargained and sold, or mentioned or intended so to be, to the said
 Jonah Kelly, his Executors, Administrators and Assigns forever; and I,
 the said Mary Jane Kelly, for myself, my heirs, executors and Administra-
 tors, all and singular the goods, household stuff and furniture, and
 other the premises, unto the said Jonah Kelly, his Executors, Adminis-
 trators and Assigns, against me, the said Mary Jane Kelly, my Ex-
 cutors and Administrators, and against all and every other person whatso-
 ever, shall and will warrant and forever defend by these presents, of
 all and singular which goods, household stuff and furniture & other
 premises, I, the said Mary Jane Kelly, have put the said Jonah
 Kelly in full possession by delivering to him the said Jonah Kelly, one
 Bed, Breakfast and furniture at the sealing and delivery of these
 presents, in the name of the whole premises, hereby bargained and sold,
 or mentioned or intended so to be, unto him the said Jonah Kelly as
 aforesaid. In Witness whereof I, the said Mary Jane Kelly, have
 hereunto set my hand and affixed my seal this 30th day of April, in the
 year of our Lord Eighteen hundred and forty seven.
