

THE COMMISSION MAY REFER TO THE CENTRAL COLLECTION UNIT FOR COLLECTION UNDER ART. 19, §§ 43 THROUGH 46 OF THE CODE A DEBT OWED TO THE COMMISSION BY A CONTRACTOR ON WHOSE ACCOUNT A CLAIM WAS PAID FROM THE FUND AND WHO IS AT LEAST 1 YEAR BEHIND IN REIMBURSEMENT PAYMENTS TO THE FUND.

(E) BANKRUPTCY PROCEEDINGS.

FOR THE PURPOSE OF EXCEPTING TO A DISCHARGE OF A CONTRACTOR UNDER FEDERAL BANKRUPTCY LAW, THE COMMISSION IS A CREDITOR OF THE CONTRACTOR FOR THE AMOUNT PAID FROM THE FUND.

REVISOR'S NOTE: This section is new language derived without substantive change from former Art. 56, § 257F.

In subsection (a)(1)(i) of this section, the former words "title" and "interest" are deleted as included in the word "right".

Subsection (b) of this section is revised to clarify that it is the duty of the Commission to provide notice.

In subsection (c)(4)(i) of this section, the former cross-reference to Art. 56, § 257E(a), now § 8-409(a) of this subtitle, is deleted as surplusage.

In subsection (c)(4)(ii) of this section, the reference to "Title 10, Subtitle 2 of the State Government Article" is substituted for the former reference to the "Administrative Procedure Act" for clarity. As to provisions governing contested cases, see Title 10, Subtitle 2 of the State Government Article.

In subsection (d) of this section, the former reference to "the Maryland Tax Refund Intercept Program" is deleted as unnecessary in light of the specific reference to "Art. 19, §§ 43 through 46 of the Code".

The Business Regulation Article Review Committee notes, for consideration by the General Assembly, that in subsections (a)(1)(iii), (b), (c), and (e) of this section, the former references to the "State Central Collection Unit" are deleted as unnecessary in light of SF § 3-304.

8-411. DISCIPLINARY PROCEEDINGS.

(A) SUSPENSION OF LICENSE.

EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, IF THE COMMISSION PAYS A CLAIM AGAINST THE FUND BASED ON AN ACT OR OMISSION OF A CONTRACTOR, THE COMMISSION MAY SUSPEND THE CONTRACTOR LICENSE UNTIL THE CONTRACTOR REIMBURSES THE FUND IN FULL FOR:
