- (2) The Office shall provide the reimbursement or make payments as provided in the State budget and account for the reimbursements and payments.
- (3) THE OFFICE SHALL MAKE PAYMENTS AND REIMBURSEMENTS CONSISTENT WITH THE POLICIES OF THE PRESIDENT AND THE SPEAKER AND THE LEGISLATIVE POLICY COMMITTEE.
- (c) (1) As soon after the end of each fiscal year as practicable, the Office shall submit a report, subject to § 2–1312 of this article, to the President and the Speaker AND THE DIRECTOR.
  - (2) The report shall contain, separately for the Senate and the House:
- (i) the name of and nature of service provided by each person to whom payment or allowance of expenses has been made; or
  - (ii) the purpose for which the payment has been made.

2-1412.

- (A) THE PRESIDENT AND THE SPEAKER MAY AUTHORIZE THE OFFICE OR A UNIT OF THE LEGISLATIVE BRANCH TO CREATE ACCOUNTS FOR REVENUES RECEIVED FROM PAYMENT OF FEES OR CHARGES AND TO UTILIZE THE FUNDS TO PROVIDE SERVICES TO INDIVIDUALS, ORGANIZATIONS, OR OTHER UNITS OF STATE OR LOCAL GOVERNMENTS.
- (B) FUNDS IN THE ACCOUNTS MAY ONLY BE EXPENDED IN ACCORDANCE WITH THE BUDGET OR BY BUDGET AMENDMENT.
- (C) UNEXPENDED REVENUES IN THE ACCOUNTS MAY REVERT TO THE STATE ON DIRECTIVE BY THE PRESIDENT AND THE SPEAKER OR MAY BE RETAINED FOR EXPENDITURE IN A SUBSEQUENT BUDGET.
- (D) THE COMPTROLLER'S OFFICE SHALL BE NOTIFIED OF ACCOUNTS CREATED IN ACCORDANCE WITH THIS SECTION.

## Article 24 - Political Subdivisions - Miscellaneous Provisions

2-101.

- (a) (2) ["Division" means the Division of Fiscal Research of] "DEPARTMENT" MEANS the Department of Fiscal Services.
- (b) If a political subdivision is authorized to incur debt to be redeemed from a fee, charge, or the proceeds of a levy, then within 120 days after the end of the fiscal year of the political subdivision, its financial officer shall submit, subject to § 2-1312 of the State Government Article, to the [Division] DEPARTMENT a comprehensive report on the financial condition of the political subdivision as of the end of that fiscal year.
- (c) A report under this section shall be on the form that the [Division] DEPARTMENT provides.
