

(II) A CERTIFICATION BY THE COUNTY TREASURER OF THAT COUNTY THAT THERE ARE NO UNPAID TAXES DUE TO THE STATE OR COUNTY ON THE GOODS, FIXTURES, OR STOCK IN TRADE; AND

(III) A CERTIFICATION BY THE MUNICIPAL CORPORATION, IF ANY, WHERE THE BUSINESS IS LOCATED THAT THERE ARE NO UNPAID TAXES DUE TO THE MUNICIPAL CORPORATION ON THE GOODS, FIXTURES, OR STOCK IN TRADE.

(4) IN THIS SUBSECTION, THE VALUATION YEAR:

(I) IN WASHINGTON COUNTY, IS THE FISCAL YEAR THAT INCLUDES MAY 1 OF THE CALENDAR YEAR WHEN THE LICENSE IS ISSUED; OR

(II) IN EACH OTHER COUNTY, IS THE LAST CALENDAR YEAR BEFORE THE YEAR FOR WHICH THE LICENSE IS SOUGHT.

(D) WASHINGTON COUNTY ZONING REQUIREMENT.

IN WASHINGTON COUNTY, THE CLERK MAY NOT ISSUE A LICENSE UNDER THIS TITLE FOR THE FIRST TIME UNLESS THE APPLICANT SUBMITS TO THE CLERK A CERTIFICATION THAT THE LOCATION OF THE BUSINESS FOR WHICH THE LICENSE IS SOUGHT HAS PROPER ZONING. THE CERTIFICATION MUST BE FROM THE COUNTY PLANNING COMMISSION OR, IF THE BUSINESS IS LOCATED IN A MUNICIPAL CORPORATION, FROM THE MUNICIPAL CORPORATION.

REVISOR'S NOTE: Subsections (a)(1), (b), (c), and (d) of this section are new language derived without substantive change from former Art. 56, § 2A(a) and (c), the first sentence of § 2, and § 12A(a) and, except as it related to the transfer of a license, (b).

Subsection (a)(2) of this section is new language added to provide a specific cross-reference to subsection (c) of this section.

Subsection (a)(3) of this section is new language added to provide a specific cross-reference to the license fees required under this title.

In subsection (a) of this section, the former specific list of licenses is deleted. The former references to a license for a "bowling alley" and for "motion picture and entertainment" are deleted as obsolete since the clerks of the circuit courts no longer issue licenses for those entities. The former references to a license for a "billiard or pool table", "chain store", a "coin-operated vending machine", a "garage", a "music box", a "restaurant", a "soda water fountain", "hawkers and peddlers", and a "construction firm or company" and to a "trader's license" are deleted as included in the defined term "license". The former reference to the "sale of cigarettes" is deleted as covered by Title 16 of this article.
