BIOGRAPHY

Theodore Roosevelt McKeldin was born in South Baltimore on November 20, 1900. His father, James A. McKeldin, was a Scots-Irish stonecutter from Baltimore, who later became a City policeman. His grandfather, also a stonecutter, was from Belfast, and may have been the son of Joseph McKeldin, also from Belfast, listed in "British Aliens in the U.S. during the War of 1812," compiled by Kenneth Scott and published by the Genealogical Publishing Company of Baltimore, 1979. Edward Hazelton McKeldin, his grandfather, was killed fighting for the Union Army at the Battle of the Monocacy, Frederick County, Maryland, on July 9, 1864, and is buried at the National Cemetery at Antietam. His mother, Dora Greif McKeldin, was the daughter of German immigrants. He married Honolulu Claire Manzer on October 17, 1935; they had two children, Theodore Roosevelt, Jr. and Clara Whitney.

In 1925, McKeldin was graduated from the University of Maryland Law School with a bachelor's degree in law. He later studied economics at Johns Hopkins University. In 1927, he established a law firm with Charles E. Moylan and Michael Paul Smith, but was immediately given a political appointment as executive secretary to Mayor William F. Broening of Baltimore because of his support during the 1927 mayoral election. He worked for Broening until 1931 when he returned to his private law practice.

Eight years later, McKeldin ran for mayor of Baltimore only to be defeated by Howard W. Jackson. He suffered another political defeat in 1942 when he opposed Herbert R. O'Conor in the Maryland gubernatorial race. However, the following year he was finally successful in his bid for the mayoralty against Howard W. Jackson.

McKeldin was mayor of Baltimore from 1943 to 1947. Among the achievements of his administration were the completion of Friendship Municipal Airport (now Baltimore-Washington International Airport); the construction of a new civic center; and the management of Baltimore's wartime economy. He also appointed the first black to the Baltimore School Board, which established his reputation as an advocate of racial intergration and civil rights.

In 1946, McKeldin was defeated in his bid for the governorship--this time by William Preston Lane, Jr. However, in 1950, McKeldin won the gubernatorial race against Lane on an anti-sales-tax platform.

As governor of Maryland from 1951 to 1959, McKeldin launched a vigorous program of reform and reconstruction, which included the Sobeloff Commission on State Government and Bureaucratic Administration and a twelve-year plan for state highway construction. He achieved nationwide prominence at the Republican Convention of 1952 when he nominated Dwight D. Eisenhower for the presidency on July 10.

In 1959, McKeldin ran for Mayor and lost to Harold Grady. He then entered into private law practice with his associate, William Adelson. In 1963 he ran for Mayor for the fourth time and narrowly defeated Philip H. Goodman by about 4,500 votes.

In his second term as mayor, which lasted from 1963 to 1967, McKeldin embarked upon a wide-ranging program of urban renewal, which included paving the way for the the development of the Inner

Harbor, construction of a new municipal building, and the elimination of the slums. He also continued to support the civil rights movement by hosting the Congress of Racial Equality which was held in Baltimore in July 1966.

After his retirement from the Baltimore political scene, McKeldin's interests and activities remained varied. In 1967, he was appointed by President Johnson to a panel of American observers which was to supervise the September elections in South Vietnam and in 1968, McKeldin spoke out against capital punishment in front of the United States Congress. He also remained a strong supporter of the state of Israel and one of the leading sellers of Israeli war bonds throughout the 1960s.

Among his many publications were The Art of Eloquence (1952) which he co-authored with John C. Krantz; Washington Bowed (1956) which was reprinted as Hats for General Washington in 1973; and No Mean City: an inquiry in civic greatness (1964).

McKeldin retired in 1968 and died on August 10, 1974.

SCOPE AND CONTENT

The Theodore R. McKeldin Papers, which cover the period 1930 to 1974, consist of speeches, the bulk of which were made during his gubernatorial career; office files, mostly from his gubernatorial years; papers from national conferences which he attended in the 1960s; books, programs, pamphlets, brochures; and other miscellaneous materials. There are also scrapbooks of newspaper articles pertaining to his career; audio-tapes of various speeches; photographs; and memorabilia.

These materials have been divided into ten series which include:

PROVENANCE

Theodore R. McKeldin donated part of this collection to the University of Maryland College Park Libraries in 1968, after he retired from public office. This accession included papers and memorabilia, and probably the scrapbooks. Additional materials—more memorabilia, plus speeches and reports—were given to the University by his wife, Honolulu Claire McKeldin in 1974, following the death of her husband. An autographed copy of McKeldin's work, Washington Bowed, was withdrawn from the University of Maryland

at College Park Libraries' general stacks in 1991 and added to Series IV.

SERIES DESCRIPTIONS

Series I: Speeches, Addresses, and Remarks, 1930-1974 (6.5 lin.ft.)

This series contains primarily McKeldin's own speeches, although there are a few addresses by other people as well. Occasionally there is a letter written by McKeldin or received by him. These miscellaneous items have been maintained in this series, since that is where they were originally found; but also because they comprise a very small portion of the files. Most of these speeches are from his gubernatorial years, typewritten on onion-skin copy paper, with some published speeches as well.

The speeches cover a wide range of topics including: state of the state addresses, budget messages, speeches on George Washington and Valley Forge, Abraham Lincoln, Theodore Roosevelt, and Woodrow Wilson. There are also addresses concerning the state of Israel, the United Nations, trade organizations, youth groups, and service clubs, as well as remarks on Negro integration, peace, religion, politics, safety, and sports, etc. This series also includes testimonials, memorials, eulogies, and campaign speeches.

The materials are arranged chronologically, and there are two indices--one by subject and one by date. The "Index to Speeches--Subject" was prepared by the processor for those speeches previously arranged topically, but now interfiled into the chronological sequence. The "Index to Speeches--Chronological" was preprepared by McKeldin's secretary and covers only the qubernatorial years. The indices may be found in Box 1.

Series II: Office Files, 1949-1965 (2 lin. in.)

This series primarily consists of information on appointments that McKeldin made while he was governor of Maryland. Two of the files concern the supervisors of elections and the commissioners of the State Accident Fund. There is also a petition of the employees of the Chesapeake Bay Ferry System seeking job security and adequate recompense and pension funding upon completion of the Chesapeake Bay Bridge, and cover letters from reports from the State Roads Commission. Other miscellaneous papers of an official nature, as well as some campaign propaganda, are also included in the series.

Series III: Conference Papers, 1966-1968 (1.75 lin. ft.)

This series contains papers relating to four major conferences which McKeldin attended in the 1960s. Those conferences were: the White House Conference, "To Fulfill These Rights" (June 1966); the National League of Cities (Las Vegas, Nevada, December 1966); the South Vietnamese Elections of September 1967; and the Timothy Dwight College conference at Yale University (March 1968). These papers are arranged chronologically by the date of the conferences and then then by type of material, which include personal notes, letters and and memoranda, newspaper clippings, publications, background information, etc.

Series IV: Books, Programs, Pamphlets, and Brochures, 1955-1973 (7 lin. in.)

This series consists of programs from church services, high school and college commencements, social organization dinners, and other affairs at which McKeldin spoke. It also contains pamphlets and brochures on buildings, parks, and other historical sites, with which McKeldin was involved as well as an autographed copy of McKeldin's book Washington Bowed. This series is arranged by type of material and then by date.

Series V: Scrapbooks, 1936-1967 (27 lin. ft.)

These scrapbooks contain a collection of newspaper clippings on McKeldin's career. The original chronological order of these materials has been preserved.

Series VI: Awards, Certificates, and Proclamations, 1956-1966 (10 lin. in.)

This series includes certificates of appreciation, awards conferring honorary citizenship of several major cities of the United States, and honorary membership certificates for service organizations and social associations. There are also copies of important documents like the Emancipation Proclamation, the Declaration of Independence for the State of Israel, and other such documents.

Series VII: Cartoons, 1942-1966 and undated (10 lin. in.) This series contains several political cartoons on or about McKeldin's career. Some of these cartoons were created by McKeldin's staff for campaign purposes.

Series VIII: Photographs, 1956, 1966, and undated (0.25 lin. ft.)

These photographs are of individuals whom McKeldin knew or groups with which he was involved. Many of these photographs are autographed. There are also depictions of buildings, ships, and historical events. These photographs have been separated from the collection and added to the Photographic Collection. The accession numbers are: 363, 936, 955-959, 974, 1095-1096, 1575-1581, 1589, 1592, 1594, 1685-1686, 7406, 11,296.

Series IX: Audio Materials, 1963 (3 lin. in.)

This series consists of three reel-to-reel tapes of political speeches given by McKeldin on April 26, May 2, and May 3, 1963. These tapes have been separated from the collection and added to the Processed Tape Collection. Two phonograph records of speeches given in 1952 are also at the University. They are found in the Phonograph Collection (Box 2).

Series X: Memorabilia, 1955-1977 and undated (98.75 lin. ft.)

This series consists of a number of plaques presented to

McKeldin by various organizations such as the American Institute of

Architects, the B'nai Brith Exodus Lodge, the Mayor's Traffic Safety

Commission, the National Law Fraternity, and other honor societies,

social organizations, and service clubs.

There is also a bronze bust of McKeldin (located in the Maryland Room), a brass name plate, and a trophy given to McKeldin. These articles have been separated from the collection and placed in the Memorabilia Collection. Accession numbers of these items are #293-311, 364, 426-427.

PROCESSING

The original order of the papers has been preserved as much as possible, although certain changes have been made. For example, a number of speeches, which were originally filed according to subject matter, have been interfiled with all other chronologically arranged speeches. An index to these speeches was prepared to capture their subject content.

An additional box of speeches was incorporated into the collection in June 1987. Headings on these folders were noted and added to the speech subject index. The speeches were then interfiled chronologically and appropriate notations were made in brackets in the chronological index. All duplicates were discarded. Some of the papers pertaining to the conferences which McKeldin attended in the 1960s were well organized, while others were not. Those papers which were already organized were kept in their original order, while the other material was arranged according to the type of material and then by date.

Staples were removed from all materials and replaced by plastic paperclips. Papers, which had suffered from water damage, had to be separated piece by piece and then paperclipped. The scrapbooks were placed in flat acid-free boxes without any further processing for preservation. All other notebooks have been dismantled, and the contents placed in acid-free folders in their original order. All files have been placed in acid-free folders and boxes.

RELATED MATERIALS

Materials related to McKeldin's terms as governor can be found at the Maryland State Archives, while mayoral materials are to be found at the Baltimore City Archives. Related materials in the collections of the Historical Manuscripts and Archives Department include a typed letter signed by McKeldin to Helen N. Coleman regarding the preservation of Lake Drive (Maryland Manuscript #2299); phonograph records of speeches made in 1952 (Budget Address to the Legislature--February 6, 1952; Speech--August 7, 1952); and two photographs of McKeldin (Photograph accession #363).
