Mrs Tawes explained to us that as her husband, the Comptroller, often used her car for official State business reasons, she saw nothing wrong in their use of a State car for personal reasons, even though that little junket last week caused the wear & tear to State property that an estimated 2000 mile round trip would cause.

Mrs. Tawes informed us that it was none of our business what her husband did with State property. Of course, we begged to differ with her. We pointed out that as a taxpayeer we are a part owner of the limosine which took her, her husband & friends in such style & comfort to Georgia, while others stayed home, or rode uncomfortable daycoaches or busses. Mrs Tawes retorted that we were the only taxpayer in Somerset who would object to such a use of a State autombile. **†** † † †

They returned Friday, May 28th. How can you expect the little fellow to save gas, to

walk, ride trains or busses, when 'the second biggest official in the State' can take such a pleasure trip at such a time? His wife, who was annoyed by our calling attention

to this trip, tells us her husband is big enough to take care of the OPA State Director, Mr. Leo H. McCormick, whom I requested by telegram to investigate on May 25th. I have since been told by local people that nothing will come of this investigation, since Mr McCormick and Mr. Tawes are said to be friends and to have gone ducking together last Fall.

I know you are a very busy man and that you have your hands full, but I really believe that until you start cracking down in Washington on the big fellows' whom everyone thinks 'can get away with' gas chiseling, you are not going to get the co-operation you need from the millions of 'little fellows.'

This man Tawes, right now, couldn't be elected dog-catcher in this county. Last Fall, he lost all but two of the men he put on his ticket. In the State, it is still a different matter. He was also the Republican, nominee-by default-simply because that Party didn't have enough fight for more than the governorship. So from a political angle, the New Deal would gain, rather than suffer, by making an example of this man who has done everything-just about-to discredit the New Deal and the Democratic Party in this county.
