

Man indicted in Carnes case

Annapolis (Special)—A 54-year-old Pasadena man was indicted yesterday by the Anne Arundel county grand jury in the October 11 shotgun slaying of Dennis A. Carnes, 24, of Riviera Beach.

Stephen R. Beard, an assistant state's attorney, said the grand jury charged Eugene W. Carroll, of the unit block Bar Harbor road, with murder in connection with the fatal shooting. Mr. Carroll is being held at the Anne Arundel County Detention Center.

Prosecutors have charged that Mr. Carroll shot Mr. Carnes once in the upper chest with a 12-gauge shotgun following a dispute in front of Mr. Carroll's house.

The argument developed, police reports said, after Mr. Carroll was forced to drive his car around five young men who were walking in the middle of the road. After Mr. Carroll parked his car in his driveway an altercation ensued. Prosecutors said the victim was then shot once in the chest and died a short while later at North Arundel Hospital.

Mandel home on another visit

Annapolis (AP)—Former Governor Marvin Mandel is back in Maryland for another home visit, but apparently plans to maintain a lower profile than on his first trip from a federal prison camp in Florida.

Mr. Mandel and his wife, Jeanne, had breakfast yesterday at their usual booth at Chic and Ruth's Delly in Annapolis. But Mrs. Mandel said her husband does not plan the whirlwind of activities he engaged in on his first visit home in July.

One reason for the low profile may be the treatment Mr. Mandel got from prison guards when he returned to Florida in July. He was placed in solitary confinement overnight after failing a balloon test used to test for alcohol consumption.

The charges were dropped after the former governor successfully challenged the procedures used in administering the test. Mrs. Mandel said at the time that she believed the treatment resulted from the governor's public activities, including press interviews he gave during the trip to Annapolis.

Because he is in the last year of his prison stay, Mr. Mandel can apply for a furlough from the camp at Eglin Air Force Base every 90 days. He will be eligible for his next trip to Annapolis in January. He is scheduled to be paroled next May.

2d Hunt Valley Mall license

The Baltimore county liquor board granted a license yesterday for a Sir Walter Raleigh restaurant in the Hunt Valley Mall, despite regulations allowing only one restaurant liquor license in a shopping center.

Jerry D. Jordan, board chairman, said the license was granted because "a majority of the board" members felt "a complex of this size" needed the additional license.

Ms. Jordan said three establishments in the area have liquor licenses and that one of those does not serve meals. Additionally, the restaurant in Bamberger's, which was granted a license last week, would serve primarily shoppers in the 765,000-square-foot mall, she said.

Sir Walter Raleigh, a chain of eight restaurants based in Gaithersburg, would serve shoppers and other patrons, W. Lee Thomas, attorney for the restaurant had argued during a hearing.

Ms. Jordan warned that the decision does not set a "precedent for all the other malls in Baltimore county" that may want additional liquor licenses. "Each case will have to stand or fall on its own merits," she said.
