Pere Wilmer's father was William Wilmer, died in Kent Co. ca. 28 Nov. 1808 and his wife Priscilla. He had three sons, Henry B. Wilmer, Peregrine Wilmer and William Wilmer.

Most likely, William Wilmer descended from the William Wilmer who married Rose Blackiston, dau. of Major Ebenezer Blackiston (1684/5 - d. ca. 21 Jan. 1746) and his wife Sarah Joyce, dau. of Thomas and Margeret, and granddaughter of Captain Ebenezer Blackiston d. 1709.

William Wilmer Sr.'s father was Simon Wilmer who died 1737 and his wife Dorcas Hynson, dau. of Charles Hynson (Thomas 1)
