> BALTIMORE, May 8. INDIANA TERRITORY. Cantonment, Wilkinsonville, 14th March, 1801.

It is my duty, (although but too well known to you) to report that yesterday evening, between the hours of four and five o'clock, a dreadful tornado willted our camp. It came in a S. W. direction, accompanied with a torrent of rain, taking along a Rirt of the quarter-master's camp, and in an oblique en N. E. over our encampments, tearing trees up by the roots, and carrying all before it, destroying a great quantity of our camp, equipage and cloathing, which is not yet accurately afcertained—and, though painful to relate, by the falling of trees, has mained and killed fome of our fellow-foldiers, of which the following is a statement.

Total killed—One ferjeant.
Total wounded—One captain, four lieutenants, two quarter-mafter ferjeants, two ferjeants, one corporal, one musician, and twenty-one privates.

One woman killed and several wounded.

Names of the officers wounded: captain Lukens, badly, lieutenants Webster, Layborne and Shiras, lieutenant Hooke's leg broke, and otherwise badly
