Prairie du Chien, 27th Aug. 1832.

Many of the officers from the Fort were present. It was a moment of much interest. The prisoners appeared in a full dress of white-tanned-deer-skins. Soon after they were seated the one-eyed Deconi rose up, and said— Mr Father-I now stand before you:

When we started, I told you I would return soon; but I could not come any sooner. We have had to go a great distance, [to the Dalle on the Wisconsin—above the Portage.] You see we have done what you sent us to do: these are the two that you told us to get[pointing to Black Hawk and the Prophet-]

My FATHER—We have done what you told us to do. We always do what you tell us,
