Assemblies and Provincial Courts to be held at Annapolis.

BE it Enacted by the King's most excellent Majesty, by and with the Advice and Consent of this present General Assembly, and the Authority of the same, That the Port of Annapolis, in Ann-Arundel County, be the chief Place and Seat of Justice within this Province, for holding Assemblies and Provincial Courts.

Writs where returnable.

II. *And* that all Writs, Pleas and Procefs, issuing, or that has issued out, and returnable to the Provincial as aforesaid, or to the Court of Chancery, shall, from the End of this present Sessions of Assembly, continue and be made Returnable to the Port of Annapolis, in Ann-Arundel County, aforesaid.
