A bill, entitled, An act making valid receipts and acquittances executed by females above the age of sixteen years, endorsed, passed by the senate January 31, 1817; and a bill, entitled, An act to enable Milcah Owings, the guardian of Caleb Daughady, Eleanor Daughady, John Stewart, Susan Stewart and Margaret Stewart, to sell and convey part of a lot of ground in the city of Baltimore, endorsed, passed by the senate January 31, 1817; which were severally read. The resolution in favour of the trustees of Charlotte Hall school, endorsed, "assented to." The resolution in favour of Robert Dunn, jun. endorsed, "dissented from." The resolution appointing commissioners to view the road therein mentioned, endorsed, "assented to with the proposed amendment;" which amendment was read and assented to. The resolution for the removal of Zebulon Hollingsworth, an associate judge of the sixth judicial district of Maryland, endorsed, "assented to," accompanied by the following message:

BY THE SENATE, January 31, 1817.

Gentlemen of the House of Delegates,

The senate have had the resolution for the removal of Judge Hollingsworth under consideration. The senate assent to the resolution generally, believing as they do that the removal of Judge Hollingsworth is required by the public interest; but in the discharge of this painful duty the senate cannot lose sight of the individual who is the object of it. The investigation made by the senate into the conduct and character of judge Hollingsworth, has satisfied them that he has failed to give that attendance on the courts which the nature of his appointment and the public interest require. But from the testimony exhibited to the senate they are not satisfied that the charge of intemperance is sufficiently supported, or that Judge Hollingsworth, from that cause has been rendered incompetent to the discharge of the duties of a Judge. With this explanation of their reasons the senate assent to the resolution.
