

On motion by Mr. Bradford, the said amendment was amended by striking out the words "is not to transfer," and inserting in lieu thereof the words "is hereby authorised to sell the same at the highest market price, but not less than par, and to apply the proceeds of such sales to the payment of the said several claims."

The question was then put, That the house adopt the amendment as amended? Resolved in the affirmative.

The bill having been read throughout and amended, the question was put, Shall the said bill pass? Resolved in the affirmative, and the bill sent to the senate.

On motion by Mr. Kell, Leave given to bring in a bill, entitled, An act to provide permanent salaries for the judges of Baltimore city court. Ordered, That Messrs. Kell, Dennis and W. Stewart, be a committee to prepare and bring in the same.

The clerk of the senate delivers the supplement to an act, entitled, An act for the relief of the poor of Queen-Anne's county, and the bill supplementary to an act, entitled, An act to incorporate a company to make a turnpike road from the city of Baltimore to Havre-de-Grace, severally endorsed, "will pass." Ordered to be engrossed. The bill annulling the marriage of John M. Cendliss and Sarah M. Cendliss, of Harford county, endorsed, "will not pass." The bill to appoint trustees for the sale of the real estate of Samuel Robertson, late of Montgomery county, deceased, endorsed, "will pass with the proposed amendments;" which amendments were read, assented to, and the bill ordered to be engrossed. And a bill to provide for schools and for the promotion of education in Caroline county, endorsed, passed by the senate February 1, 1817; which was read.

The house adjourns until this evening 5 o'clock.
