Resolved by the general assembly of Maryland, That the treasurer of the western shore pay to the executors or administrators of the late Sutton I. Weems, esq. the sum of eighty-four dollars, the amount of his per diem from the twenty-sixth of February, eighteen hundred and twenty-five, until the nineteenth of March last; and that his funeral expences be placed upon the journal of accounts.
