

The report on the petition of Thomas Weedon, was read the second time and concurred with.

The resolutions in favour of John Blake, Conrad Coffroth and James Crawford, were severally read the second time, assented to, and sent to the senate.

Mr. Brohawn has leave of absence for a few days.

The bill to limit the operation and effect of mortgages; the bill to alter and change the names of John A. Johnson, and others; the bill to compensate the trustees of the poor of Caroline county for their services, were severally read the second time, passed, and sent to the senate.

On motion by Mr. Grubb, the bill for the benefit of the stockholders of the Susquehannah bridge, was made the order of the day for the 30th inst.

On motion by Mr. Speed, Ordered, That the bill, entitled, An act to repeal an act to compensate the Adjutant General of this state, be made the order of the day for to-morrow.

The bill for the relief of Charlotte Schwartze, of Washington county, was read the second time, passed, and sent to the senate.

The bill to authorise the levy court of Frederick county, to levy a sum of money to purchase a tract of land, and build a house thereon for the use of paupers, and to sell the present poor house of said county, and for other purposes, was read the second time, passed, and sent to the senate.

Mr. Millard obtained leave to withdraw the bill to divorce Eve Feezer, for amendment.

On motion by Mr. Millard, Ordered, That the bill to authorise the orphans courts of this state, to order the sale of real estates in certain cases, have a second reading on the 24th inst.

The bill to change the name of Octavius Wilkinson, and others.

The further additional supplement to the act, entitled, An act to establish the line between Frederick and Washington counties, passed November session 1810, chapter 6.

The bill for the relief of Nancy Vissage; the bill relating to suits on bills of exchange, promissory notes, and other negotiable instruments; and the bill for the relief of Ann M. Beatty, were severally read the second time, passed, and sent to the senate.

Mr. Millard reports the bill to divorce Eve Feezer, as amended; which was twice read by special order and passed.

The house according to the order of the day, proceeded to the second reading of the additional supplement to an act, entitled, An act for quieting possessions, enrolling conveyances, and securing the estates of purchasers.

On motion by Mr. Speed, the following was added as an additional clause:

And be it further enacted, That the clerks of the several county courts of this state are hereby authorised to record any deed or conveyance executed and authenticated agreeably to the provisions of this act.

On motion by Mr. Montgomery, the following was added as an additional section:

Sec. 3. And be it enacted, That all acts, or parts of acts heretofore passed, that may be repugnant to, or inconsistent with the provisions of this act, be and the same are hereby repealed.

The bill was then passed.

The house adjourns until to-morrow morning 10 o'clock.
