Present as on yesterday.

The State Boat Dolphin was taken into the Continental Service & on 26th May -

Ordered That the Company of Stores deliver to Paul Richards of the 3^d Regiment

1 pair of Stockings and 1 pair of Leather Breeches.

That the western shore Treasurer pay to William Hyde Ten thousand Pounds for the use of Col^o Henry Hollingsworth on account.

That the said Treasurer pay to James O'Hara Two hundred Pounds allowed to him by this Board from the 16 February last to this Inst. by virtue of a Resolve of the General Assembly passed the 7th of August 1779.

That the said Treasurer pay to Robert Dorsey Esq^r five thousand Pounds to be delivered over to David Poe Esq^r on account.

Monday 1st May 1780.

Present as on Saturday.

Ordered That the western shore Treasurer pay to Robert Reith a Messenger to the Governor Council one hundred and twenty five Pounds for his Salary to this Inst.

That the said Treasurer pay to Capt. William Middleton, four hundred and two Pounds, fifteen shillings on account.

That the said Treasurer pay to William Hyde, four hundred and fifteen Pounds, thirteen shillings and four Pence due him as Asst. Clerk to the Gov^o Council this day.

That the said Treasurer pay to Thomas Johnson Junr. four hundred and fifteen Pounds, thirteen shillings and four Pence for 1 Mo. Salary due this Inst.

That the said Treasurer pay to Jesse Lillie one hundred and sixty eight Pounds, fifteen shillings due him per a Res^o passed by the Dep^y Aud^r.

Commission issued to William Middleton appointed Capt of the Schooner Boat Dolphin in the service of this State.

Tuesday 2^d May 1780

Present as on yesterday.

Ordered That the western shore Treasurer pay to John Chalmon, three thousand five hundred Dollars for 1200^{lb} of Madfish purchased of him by this Board for the Continental Troops in this City and Delivered to M^r Small.

That the said Treasurer pay to Esq^r Richard Chew one hundred & twenty two Pounds, twelve shillings and six Pence due him of account passed by the Aud. Gen^l.

That the said Treasurer pay to Doct. James Murray one hundred & sixty three Pounds due him per a Res^o passed by the Aud. Gen^l.

That the said Treasurer pay to Col^o Noah Forest one thousand and forty one Pounds, sixteen shillings and four Pence due him for 1 Month Salary as a Gen^l.

That the said Treasurer pay to John Sand, one hundred and twelve Pounds ten shillings due him of account passed by the Dep^y Aud^r.

That the said Treasurer pay to Capt Will^m Middleton five hundred Pounds on account.
