That the said Treasurer pay to Daniel Canoll Esq. Twenty six Pounds of the new Emission in lieu of an order of the 14<sup>th</sup> July last.

That the said Treasurer pay to Thomas Gasparway Depy Aud. Fifteen Pounds twelve shillings and six Pence of the new Emission in lieu of six hundred and twenty six Pounds for 1 Month Salary to the 1<sup>st</sup> Inst.

That the said Treasurer pay to James Todsell one hundred and forty three Pounds and three pence of the new Emission in lieu of five thousand seven hundred and twenty Pounds, twelve shillings and six pence to be delivered over to Hughes and Williamson for 7 pieces of Iron purchased for the Officers of the Maryland Line by J Randall of the order of the 16 May last.

That the said Treasurer pay to Col. James Todsell one thousand nine hundred and eleven Pounds, three shillings and nine pence of the new Emission to be delivered over to Ridley and Springle on Account.

That the said Treasurer pay to Thomas Dummoek two Dollars of the new Emission in lieu of seventy two Pounds due him of and passed by the Depy Aud.

That the said Treasurer pay to His Grace Thomas Lord Lee Esq. Forty three Pounds fifteen shillings of the new Emission in lieu of one thousand seven hundred and fifty Pounds Bal<sup>d</sup> of an Order of the 25 July last.

That the said Treasurer pay to James Murray Esq. seventy two Pounds of the new Emission in lieu of three thousand Pounds due him as Judge of the Court of Appeals from May 1779 to 5 of October 1700.

That the said Treasurer pay to Benjamin Rumsfy Esq.
