Ordered That the western shire Treasurer pay to Robert Reynolds twenty one pounds, two Shillings of the Bills emitted under the Act for the Emission of Bills of Credit not exceeding two hundred thousand pounds Year of the money appropriated for the payment of Esquires due his allowance on the Journal of a May Session 1701.

That the said Treasurer pay to Lieut John T. Lowe, Lieut John Scaw of the 5th Regim^t, Capt James Somerville of said Regim^t, each, Twenty pounds of the same Emission of the money appo^d to the Off^r going to the southw^d.

That the said Treasurer pay to Lieut John T. Lowe four pounds, four Shillings and six pence of the same Emission of the money appo^d for the present Campaign, in lieu of Cloathing past passed by the Aud. Genl -

That the said Treasurer pay to Solomon Sparrow Twenty five pounds of the same Emission of the money approp^d as aforesaid per Account passed by the Aud. Genl -

That the said Treasurer pay to Edward Gaither jmt. purchasing Commissary for Ann Arundel County fifteen pounds of the same Emission of the money appropriated as aforesaid on account -
