

An Act for the better regulation of the said Province of New Brunswick
 passed the sixth day of June in the first year of the said Majesty King George the Third
 and six hundred thirty three continued until the third day of October
 following & from thence continued until the second Tuesday in October
 One thousand six hundred sixty & six Entitled an Act relating to
 upon Sabbath days & day of God's Master and training. One other act in
 the same Assembly Entitled an Act for the better regulation of the said
 Courts. One other act made the same Assembly Entitled an Act concerning
 proceedings at Law except one Clause in the same and thereof vizt. so far
 as the Court shall Judge them not inconsistent with the condition of the Province
 which is not to be revised. One other act made the same Assembly Entitled an
 Act against the Exportation of Wool & Old Iron. One act made at a General
 Assembly held at St. Marys the twentieth day of April One thousand six hundred
 sixty & six Entitled an Act relating to the Indians for any stolen
 or alive excepted & Wildfowl. One other act made the same Assembly
 Entitled an Act relating to Foreign Inhabitants. One act made at a General
 Assembly held at St. Marys the thirtieth day of April One thousand six hundred
 sixty & six Entitled an Act for the better regulation of certain accounts for
 averaging suits at Law. One other act made the same Assembly Entitled an Act
 for providing sufficient freight & Carriage for the goods & commodities of this
 the Province & the Governor of this Province for the time being.
 One other act made the same Assembly Entitled an Act limiting & extending
 of Attachment & providing what shall be levied upon Attachment & Execution which
 other Act made the same Assembly Entitled an Act providing what shall
 be good Evidence to prove foreign debts. One other act made at a General
 Assembly held at St. Marys & from the twentieth day of March One thousand
 six hundred seventy & One Entitled an Act against the use of false money. One
 other act made the same Assembly Entitled an Act against the use of false money. One
 other Act made the same Assembly Entitled an Act for & providing a standard
 with English Weights & measures in the several respective Counties within
 this Province. One other act made the same Assembly Entitled an Act
 relating to Importation of all Horses Geldings, Mares & Colts into this
 Province. One Act made at a General Assembly held at St. Marys the twentieth
 day of October One thousand six hundred seventy & One Entitled an
 Act for Explanation of one Clause in an Act Entitled an Act relating
 to the Importation of all Horses Geldings, Mares & Colts into this Province vizt.
 in Addition & amendment thereto. One other act made the same Assembly
 Entitled an Act for marching high waves & making the heads of Rivers
 brooks branches & swamps passable for horse & foot. One other act made the
 same Assembly Entitled an Act for stay of Execution after appeal Court
 One act made at a General Assembly held at St. Marys the thirtieth day
 of April One thousand six hundred seventy & six Entitled an Act
 concerning the Imparcelling the grand Ingham in the several Counties
 within this Province. One other act made the same Assembly Entitled
 an Act for & Surveying the said Ingham with Addition of fees upon Landlords & Leasors
 vizt. the same. One other act made the same Assembly Entitled an Act for
 payment of fees due from Criminals & from One other act made & same Assembly
 Entitled an Act concerning those servants & Slave Bastards. One other act
 made the same Assembly Entitled an Act against burnings of Houses &c.
