Wm Jarvis and Rob^t Morris their Complying with what is required
of them by this Act that they the said Wm Griffin Wm Jarvis and
Robert Morris and either of them their and either of their heirs Ex^{rs}
or adm^{rs} shall be by Verue of this Act acquitted Exonerated Released
and Discharged of and from all Manner of Debt^s Dutys Claims and Demands
whatsoever that have been severally Contracted by them or have Arisen
Due or become Demandable from them at any time before the sitting of
this present Generall Assembly and that in Case the said Wm Griffin
Wm Jarvis & Robert Morris or either of them shall after their
Compliance and Discharge as aforesaid be arrested or sued for any such
their Debt^s ~~and~~ ^{or} Dutys as aforesaid or that the said Sherr^{ts} shall be sued
for any Matter or thing required of them or either of them to be Done
by this Act that then the said Wm Griffin Wm Jarvis and Robert Morris
or the said Sherr^{ts} or either of them whensoever it may Concrene may Enter a
Common Appearance or Appearances without Special Bayle to any
such Action or Actions as shall be brought against them any or either of
them and plead thereto the Generall Issue and give this Act or the
Exemplification thereof with other Special Matter thereon Arising in
Evidence and that in Case the pl^{ff} or pl^{ff}s Comencing and bringing such
Action or Actions as aforesaid shall be Absent the Defend^t or Defend^{ts}
shall Moreover against him or them Double Costs of Suit any Law Statute
Usage or Custom to the Contrary notwithstanding And be it further Enacted
that the Sherr^{ts} of the Severall and Prospective Countys aforesaid and either
of them shall after such Surrender and Delivery up as aforesaid give publick
Notice at the Churches Court houses and Mills within the said Countys of
some precise time by them the said Sherr^{ts} and the said two Justices to be
Appointed for the Distribution of the said Wm Griffin Wm Jarvis &
Robert Morris their Effects and Estate not less than twenty Days after the time of the making the said Surrender
and shall then and there in the presence of two Justices as aforesaid and by their Advice and Directions Make Distribution
of the Estate or Estates of the said Wm Griffin Wm Jarvis and Robert Morris or of the Estate or Estates of either of them as aforesaid to be
