In what Manner the aforefaid 900 l. is to be repayed.

And that the Credit of the faid Office for emitting Bills of Credit, e. stablished by A& of Assembly, may be the hetter supported, and for Repayment of the faid Sum of Nine Hundred Pounds into the Office aforesaid, Be it Enasted by the Authority, Advice, and Consent afore. faid, That fuch, and to much, of the hefore mentioned Act of Assembly, Entituled, An Act for issuing and taking out of the Office of the Commissioners or Trustees appointed for emitting Bills of Credit, established by Act of Assembly, the Sum of Four Thousand Five Hundred Pounds Current-Money, for Encouragement of Juch able-bodied Freemen as shall voluntarily enlist themselves into his Majesty's Service, for the intended Expedition against Canada, and for maintaining and conveying them to the Place of Rendezvous: As also for replacing of the said Sum; and for the better regulating Ordinaries and Ordinary-Keepers, and for sther Purposes therein mentioned, to tar as relates to the regulating of Ordinaries, Ordinary-keepers, granting Ordinary Licenses, with the several Clauses, Matters, and Things therein mentioned concerning the same, shall, from and after the Payment of the Sum of Four Thousand Five Hundred Pounds Current Money, therein directed to be paid, into the said Office, be, remain, and continue in full Force and Virtue for and during, and until such Time as the aforesaid Sum of Nine Hundred Pounds, now taken out of the same Office, to the Uses of this Ad, shall be fully compleated and paid into the said Office unto the Commissioners or Trustees aforesaid for the Time being, and to the End of the next Session of Assembly which shall happen after such Completion and Payment.

Commissioners of the said Office to receive all the Moneys arising by Virtue of this Act. And he it further Enasted, That the Commissioners or Trustees of the Office aforestaid for the Time being, shall, and they are hereby impowered and directed to receive all Moneys arising, or which shall arise, by Virtue of the said Act hereby continued; and when so received, to place the same to the Credit of an Account to be by them stated and kept, to the Uses and Purposes of this Act; in which Account the said Commissioners or Trustees for the Time being shall charge Debtor the Payments hereby directed to be made, to and for the Uses of this Act. And that in cass, during the Continuance of the last recited Act, any more Money shall be raised or paid to the Commissioners or Trustees aforesaid, in Virtue there of, than the said Sum of Nine Hundred Pounds; that the Surplus or Remainder shall be, and is hereby directed to be appropriated and applied to mainder shall be, and is hereby directed to be appropriated and applied to wards Discharge of the public Expences of this province, as the General Assembly thereof for the Time being shall direct and appoint.
