Cent for Collection. And that the Rector, Vestrymen and Churchwardens of the said Parish, for the Time being, or the major Part of them, are hereby authorized, directed and required to agree and contract with a Workman, or Workmen, to undertake, build, finish and compleat the Addition to the said Parish Church, as also to make the necessary Repairs to the same as it now stands, in a Workman-like Manner.

And he it further Enacted by the Authority, Advice, and Consent a-foresaid, That the said Rector, Vestrymen and Churchwardens, or the major Part of them, be, and they are hereby authorized and impowered, from time to time, as Occasion shall require, for the Purposes atoresaid, to draw upon the Sheriff of Churles County, in whose Hands the atoresaid Quantity of twenty-seven thousand Pounds of Tobacco, so as aforesaid to be assessed and levied, or such Part thereof as shall by Vietue of this Act be so assessed and I vied. Shall remains for so much of the said Tobacco as they the said Rector, Vestrymen and Churchwardens, or the m jor Part of them, shall from Time to Time think it necessary to draw for, towards Satisfaction or Payment for building, sinishing and compleating the Addition to the said Church, or repairing the same as it now stands: And he said Sheriff shall be, and he is hereby authorized and obliged, from time to time, to pay the same to such Orders accordingly, so far as the said Sum shall extend unto.

And be it further Enacted by the Authority aforesaid, That it shall and may be lawful for the said Rector, Vestrymen and Churchwardens, or the major Part of them, and they are hereby directed and required to sell and dispose of, for the best Price that can be got, all the said Stock of Neat Cattle and Swine belonging to the Gebe of William and Mary Parish as aforesaid, at the most proper Seasons of the Year, by the said Rector, Vestrymen and Churchwardens, at public Auction; and the Money or Tobeco arising by such Sale to be applied toward the repairing the said Glebe, and other necessary Charges of the said Parish.

An Act impowering the Justices of Prince George's County to levy on the taxable Inhabitants of Queen Anne Parish, in the said County, Fifty Pounds Current Money, for the Uses therein mentioned.

HEREAS, the Rector, Vestrymen and Churchwardens of Preamble, Queen Anne Parish in Prince George's County, have by their humble Petition to this present General Assembly set forth, that their Yard belonging to their Chapel now lies open, and that there is no House to accommodate the Minister and Parishioners in bad Weather; and have therefore prayed that an Act may pals, impowering the Justices of Prince George's County to levy on the taxable Inhabitants of the said Parish sitty Pounds Current Money, to be applied towards the paling in the said Yard, and building a House with a Fire-place, for the Purposes aforesaid.

Be it therefore Enacted by the Right Honourable the Lord Proprietary, by and with the Advice and Consent of his Lordship's Governor, and the Upper and Lower Houses of Assembly, and the Authority of the same, That the Justices of Prince George's County for the Time being shall, and they are hereby authorized and directed, at their Court to be held at next November, to assess and levy on the taxable Inhabitants of Queen Anne Parish, the Sum of Fifty Pounds Current Money, together with the She[May, 1750.]

50% to be lest vied on the Ichabitants of Queen Anne Parish.
