And be it further Enasted, That in Case of the Death of any, or Death, Refu-fal, or Inabi- either of the said Officers, so nominated and appointed, or the Refusal or Inlity, the Com- ability of them, or either of them, to act, the said Commissioners, or the major Part of them, shall, as soon as conveniently may be, thereafter, meet together, and nominate and appoint one other such Person, as aforesaid, in the Stead and Place of any Person so dying, refusing, or becoming incapable to act, for the Residue of the Year then to come; and if the said Commissioners, shall neglect and omit, to nominate and appoint, all, or any of the said respective Officers, then, and in such Case, the Governor or Commander in Chief, of this Province, for the Time being, may, by Warrant, under his Hand, constitute and appoint, all, or any of the said Officers, who shall have the like Power and Authority, as if they, or either of them, had been, by the said Commissioners, regularly nominated and appointed.
