mistaken construction of the powers of this act of incorporation intended to be CHAP. granted, any ordinance, resolution or act, should be made, or any matter done transacted, by the said corporation, contrary to its powers and authorities hereby granted, and though all fuch ordinances, resolutions or acts, should be void, yet they shall not by the general assembly, nor any court of law, be deemed or adjudged a forfeiture of this act of incorporation, but the same shall be and remain inviolable and entire to the faid corporation, in perpetual succession; and all their acts, conformable to their powers, shall remain in full force and validity, the nullity of such illegal acts notwithstanding; and this act of incorporation and constitution of government, and every part thereof, shall be good and available in all things in the law, according to the true intent and meaning thereof, and shall be construed, reputed and adjudged, in all cases, most favourably to the faid corporation, and their successors, for ever; provided always, that the whole may be annulled, or any part thereof changed or altered, with the concurrence of two fuccessive legislatures.

And he it enacted, That this act of incorporation and constitution of Commencegovernment shall commence and be in force on the first day of January, in the year seventeen hundred and ninety-five, if the same shall be confirmed by the general affembly at their fession in November, one thousand seven hundred and ninety-four, and not otherwise.

HEREAS doubts have arisen, whether the commissioners appointed Preamble. by any county court, under the act for marking and bounding lands, have power to summon and swear evidences to prove and perpotuate the bounds of the petitioner's land, notwithstanding the same may have become uncertain, obfolete and decayed; therefore,

II. Be it enacted, by the General Assembly of Maryland, That when any com- Commissionmission shall hereaster be issued by any county court, under the act for marking summonses, and bounding lands, the commissioners therein named, or a majority of them, &c. shall have full power and authority to issue summonses for all persons nominated by the petitioner, or other person affected, or to be affected thereby, and to administer an oath, or affirmation, to them, touching their knowledge of the poundary or boundaries to be perpetuated, and take depositions respecting the same, and make return thereof, with their other proceedings, to the county fourt, to be recorded; and the same, when recorded, shall be as good evidence, law or equity, as if a commission for that purpose alone had been issued under the act, entitled, An act for the ease of the inhabitants in examining evidences elating to the bounds of lands, and in the manner of obtaining injunctions, any aw, usage or custom, to the contrary notwithstanding.

III. And be it enacted, That in case any of the said witnesses, when so as And apply for foresaid summoned, shall not attend, the commissioners, or any two of them, attachments, hall apply to the clerk of the county for an attachment, which shall issue acordingly, to compel their attendance.
