WHEREAS, It is represented to this General Assembly, by the petition of sundry inhabitants of Caroline county, tirct Dover Causeway is kept up for the use and benefit of the Choptank Bridge Company, at an enormous expence to the

Sec. 1. BE IT ENACTED by the General Assembly of May contract. Maryland, That it shall and may be lawful for the president and directors of the Choptank Eridge Company to contract with the levy court of Caroline county, for the passage of the citizens of said county over said bridge, for a sum of money not exceeding three hundred dollars annually, to be levied on the assessable property of said county, and collected as other county charges, and paid over by the collector of said county, to the president and directors as aforesaid, or to any person au, thorised by them to receive the same. 2.
