The bills entitled, An act to promote the rectuiting fervice, was read a fecond time, and

In the fifth line of the first page, between the words "money" and "verified," insert the following, "or two thousand pounds of tobacco." Strike out the word "and" in the third line of the second page. After the word "soldiers," in the fixth line of the same page, insert the following, "And be it enacted, That the creditors aforesaid shall not be affected by the act of limitations, from and during the time they shall be precluded, as aforesaid, from prosecuting their claims; nor shall the delay of suing out execution during such time operate so as to prevent the suing out the same, after the discharge of such debtors from the service." In the eleventh line of the second page, strike out the words "including an allowance," and instead thereof insert the following, "and in every such case the magistrate shall deduct from the value of the said servant or apprentice the sum." In the third line from the bottom of the second page,

insert the word "immediately" between the words be' and " paid." Strike out the two last clauses and insert the following: "And be it enacted, that the governor shall appoint a proper and discreet person in every hundred in each county of this state, who shall repair to and require every, house-keeper, within his hundred, except tavern-keepers, to deliver in an account of all the blankets the property of the faid house keeper, over and above the number necessary for and commonly used by the family in the winter season, and shall deliver to the faid collector one third part of the faid overplus. And if the faid collectors shall suspect a concealment by any house-keeper, then the faid collector shall tender to the faid housekeeper the following oath or affirmation, viz. I, A. B. do swear, or affirm, that I will deliver in to the best of my knowledge a just and true account of the number of blankets belonging to me, over and above the number necessary for and commonly used by my samily in the winter season; and the faid houle-keeper shall deliver to the said collector one third part of such overplus 2 and the faid collector shall deliver to every house-keeper, or his assigns, a certificate of the number and value of the blankets to as aforesaid received by him, which value thall be afcetteined either by agreement, or by the appraisement, on oath, of an indifferent person, to be administered by the collector, and be paid by either of the treasurers of this state, who shall transmit, with all convenient speed, to the governor and council, fair and exact lists of the number of blankets, and from and by whom collected; and the said collectors shall, without loss of time, convey to and deposit in the public store at Annapolis, the blankets collected in their respective hundreds, to be delivered out on the order of the governor and council, for the public we sand if any fuch housekeeper shall resuse to render such account of blankets, upon oath or affirmation, as aforesaid, or shall refuse to deliver such proportion of the overplus as aforesaid, such house, keeper shall forseit

fuch refusal to the grand jury of the succeeding court.

6. And, whereas the inhabitants of several parts of this state have on former occasions supplied blankets to the regular troops or militia, Be it therefore enacted, that no blanket shall be required of any house-keeper, who shall make it appear, to the satisfaction of any collector, that he or shall heretofore supplied any number of blankets, for the use of any regular troops or militia, equal, in the opinion of such collector, to what such house-keeper might be required to supply in virtue of this act, but if not equal, then a deduction shall be made of the number heretofore supplied, out of the number which such house-keeper might otherwise be obliged to deliver.

the sum of twenty pounds current money, to be recovered in the county court of the county where such house-keeper resides, for the use of the state, by indictment or action of debt; and the said collector to whom such refusal shall be made, is hereby required to give information of

by them respectively collected, and shall be allowed their reasonable charges for conveying them to the public flore in the city of Annapolis.

on the execution of his said office, take the following oath, before some justice of the peace, viz.

A. B. do swear, that I will impartially, saithfully, and diligently, discharge the several duties of collector, according to an act, entitled, An act to promote the recruiting service.

And be it surther enacted, That no debtor shall be discharged from the civil process of his creditor, nor servant from the service of his master, who shall enlist into the service after the last day of November next, any thing in this act to the contrary notwithstanding."
