YOUR bill, entitled, An act concerning duties, would operate as an effectual repeal of all which have been heretofore imposed by acts of assembly of this state, and seems to imply a promise that no duties whatever shall hereaster be taken. We cannot but think it improper, so near the end of the session, to go into a revisal of all those laws and consider the propriety of repealing the whole by a perpetual act; we have therefore amended the bill so as to suspend all the acts imposing duties so far as they relate thereto, except on negroes, for two years, before the expiration of which time, we hope our commercial affairs will wear a more promising aspect. A general revisal of the laws relative to trade may be proper, and we shall be better able to form a Tystem for the regulating our commerce. R. POTTS, cl. sen.
