His excellency the governor communicates to the senate a letter from Henry Laurens, Esq; president of congress, of the 24th of April, enclosing an act of congress for detecting disaffection, and defeating conspiracies and insurrections in the state of Delaware and eastern shore of Maryland, and copies of several letters to the same purport: A letter, of the 27th of April, enclosing aels of congress for tansporting public provisions and stores across Chesapeake bay, and recommending to the several states to grant pardons to persons who have adhered to the enemy; a letter and act of the 5th of May, recommending to the legislatures of the several states to enact laws for the exemption of persons employed in manufacturing military stores for the United States from militia duty: A letter and act of the 8th of May, for making known to the public such parts of the treaties of commerce and alliance with France as congress have judged necessary to be published, and the ratification of the same: A letter of the 11th, enclosing an address of congress to the inhabitants of the United States, and a proclamation for restraining the conduct of captains, commanders, and other seamen belonging to American armed vessels: A letter of the 26th, enclosing an act of congress, recommending to the several states to exempt from militia service, and to disqualify from acting as substitutes, all prisoners and deserters from the British army and navy: A letter from general Washington, of the 4th of May, informing, that congress, by an act of the 26th of February, had annexed the German battalion to the state of Maryland, and requiring the assistance of this state in recruiting the same, and a letter of the 17th, requesting the governor to detach five hundred militia to guard the public stores lodged at the head of Chesapeake bay: A letter from general Smallwood, on the same subject: And a letter from major Lee, of the light dragoons, enclosing instructions to capt. Lindsay, relative to the seizure of horses, for the dragoon service, on the peninsula between Chesapeake and Delaware bays, by virtue of powers from the board of war. Which were severally read.
