VOTES AND PROCEEDINGS, OCTOBER, 1778.

T U E S D A Y, November 10, 1778.

HE senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

The petition of Gabriel Childs, of Calvert county, praying an act may pass the legislature to invest a tract of land purchased of a certain John Allton, deceased, in him and his heirs, agreeable to the tenor of said petition.

The petition of Eleazor M'Comb, of Kent county, praying an act of the legislature to aid a defect in a deed for two lots of land lying in Chester-town, purchased by him of a certain Trum-

bull, of the island of Barbados.

The petition of John Gorsuch, of Baltimore county, soliciting the aid of the legislature, relative to the alteration of the record of both certificate and patent of a tract of land called Ensor's Inspection, lying in said county, and praying to be relieved against such fraud.

The petition of Mary Crooks, widow and relict, and Henry Crooks, executor, of William Crooks, late of Harford county, deceased, praying the legislature to establish the last will and

testament of said Henry Crooks.

The petition of fundry tailors, of Baltimore county, praying an act might pass the legislature

establishing them into a body corporate.

The petition of Elizabeth Fairbank, wife of Philemon Fairbank, setting forth, that her husband being in a state of infanity, had not taken the oath of sidelity in the time prescribed by law, and therefore praying the legislature to pass an act exempting him from the penalties inslicted on nonjurors; were severally read, and sent to the house of delegates by William Hindman, Esq; The bill, entitled, An act for the relief of sundry inhabitants of this state, was read a second

time by especial order, passed, and sent to the house of delegates by Thomas Jenings, Esq;
The bill, entitled, An act to revive and aid the proceedings of Talbot county court, was read

a second time by especial order, passed with the following amendments:

Strike out the words "in any action so discontinued" in the second line of the second proviso, and insert the following; "given to the sheriff for the appearance of any person or persons on any writ or process returnable at the said August court." Strike out the last enacting clause.

The following message was sent to the house of delegates by Matthew Tilghman, Esq;

By the SENATE, November 10, 1778.

Gentlemen,
AS this state is unrepresented in congress, and matters of the greatest moment, we are informed, are now under the consideration of that body, we think an immediate representation necessary, and therefore, if agreeable to your house, we propose to ballot this day for delegates to congress, immediately after the choice of counsellors to the governor.
