THE senate met. Present as on yesterday. The proceedings of yesterday were read.

The bill, entitled, An act to procure a loan, was read the second time by especial order, passed, and sent to the house of delegates by Thomas Stone, Esq;

A letter from his Excellency the governor was communicated to the president, expressing doubts as to his power in the remission of fines by the constitution, and soliciting the general assembly's advice and opinion thereon, enclosing a petition from Pearce Lamb, directed to the governor; which were read and referred to the consideration of the house of delegates.

Messieurs S. Hanson and M^rBryde, from the house of delegates, deliver to the president the engrossed bill No. 2, with the paper bill thereof, which engrossed bill was thus endorsed; "By the house of delegates, June 14, 1780: Read and assented to.

No. 2. An act to procure a loan.
