RESOLVED, That the governor and council be requested to order the public wheat collected and remaining on hand in Cecil, Kent, Queen-Anne's, Harford, Baltimore, and Anne Arundel counties, and at Bruce's, Lantiss's, and Ogle's Mills, in Frederick county, to be manufactured, with all dispatch, into fine and superfine flour, and to order immediate returns to be made of all wheat and flour in those counties.

Whereas the barge Experiment, the property of an individual on the eastern shore, was lately employed in the public service, and while in that service lost her sails and oars, and a pair of swivels, and received considerable damage in her hull,

RESOLVED, That the special council be directed immediately to refit the said barge, and furnish her with sails and oars, and a pair of swivels.

Messieurs Morris and Sprigg, from the house of delegates, deliver to the president the following resolutions:

BY THE HOUSE OF DELEGATES, MAY 29, 1781.

RESOLVED, That the governor and council be requested to take the most expeditious methods to procure the necessary cloathing for the troops to be marched to the southern army, and that they apply so much of the flour now on hand, or as may be ground in consequence of the resolution of yesterday, as may be sufficient to defray the expence of the said cloathing, and that they employ in their discretion special agents for that purpose.

RESOLVED, That the governor and council be requested to make sale of so much flour as may be sufficient to raise the sum of fifteen hundred pounds specie, and that they pay to each of the officers in this state, who are ordered to the southward, the sum of thirty pounds specie, and that they send the like sum to each of the officers of this state who are now in the field.

RESOLVED, That the commissioners to preserve confiscated British property sell the bar iron on hand at the Long-Calm forges for specie, and lodge the same with the governor and council, to be applied to the above purposes.
