No. 64. A supplementary act to the act, entitled, An act to incorporate the managers of

Back-creek school.

No. 65. An act to limit the time for bringing and fettling claims against this state.

No. 66. A Supplement to the act for making the river Sufquehanna navigable from the line of this state to tide water.

No. 67. An act to invest congress with certain powers respecting the commerce of the United States.

No. 68. An act to settle and pay the civil list, and other expences of civil government.
