The senate, having previously qualified agreeably to the constitution and form of government, proceeded in election of a governor; the ballot box being prepared, the ballots were deposited therein, sealed up, and vered to the committee of the senate appointed to meet the committee of the house of delegates, who retire the conference room, and after sometime returned and reported, that Edward Lloyd, of Wye, had eighty votes, Charles Carroll, of Carrollton, four votes, and Benjamin Stoddert one vote.

Whereupon it is declared in the senate, that Edward Lloyd, of Wye, is duly elected Governor of Maryland

The senate adjourns until to-morrow morning 9 o'clock.
