Bowie and Daniel Murray, for the Farmers' bank of Maryland, at Annapolis; Fenchighman and James Price, for the Branch bank at Easton; Joseph McIlhenny and John Harry, for the Hagerstown bank, and William Alexander for the Elkton bank of Maryland, having had a majority of votes, are duly elected directors on the part of the state for and during the term prescribed by law.

FRIDAY, January 6.

The senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

The bill entitled, an act to lay out and open a road in Frederick county was read the second time and will not pass.

The bill entitled, an act authorising a sale of the real property of which Gabriel G. Van Horn died possessed, was read the second time and will not pass.

The clerk of the house of Delegates delivers a bill entitled, an act to lay out and make publica road in Baltimore county. A bill entitled, an act relating to the fees of the clerk of Prince George's county. A bill entitled, an act to lay out, open and establish a new road in Washington county. And a bill entitled, an act authorising George Washington Thomas, to collect all balances due Edward Wilkins, late sheriff and collector of Kent county, severally passed by that house January 6, 1815. Which were severally read the first time and ordered to lie on the table.

The bill entitled, an act to incorporate the Bellona gun powder company of Maryland. And the bill entitled, an act for the relief of Philip German, jr. of the city of Baltimore, were severally read the second time and will pass.

The bill entitled, an act to straighten certain roads near the Little falls of Gun-Powder, was read the second time and will pass.

The bill entitled, "an act to lay out and make public a road in Baltimore county," was read the second time and will pass.

The bill entitled, "an act to reinstate in the county court of Alleghany county, the proceedings of a case therein mentioned," was read the second time, and will pass with the proposed amendments.

*Amendments proposed.*

1st Strike out the preamble.

2d Strike out the words "judges of," in the second line of the first enacting clause, and the same words in the first line of the second enacting clause.

3d Strike out the words "the said," in the last line but one of the first enacting clause.

4th Add, at the end of the first enacting clause, "it being represented that the subject in controversy was not fully brought before said county court."

5th Strike out the last enacting clause and insert "provided always and be it enacted, that the present road as laid out by the levy court shall be free for the use of the said David Shriver, until a final decision shall be made in the premises; and provided also, that should the road be located in another or different direction, the said David Lynn shall not be entitled to any damages for either of said roads. And be it enacted, that upon a revision of the said case, the county court shall allow to the said David Shriver such costs as they may adjudge reasonable."
