

The bill entitled, "an act relating to the records of Prince George's county," was read the second time, and will not pass; sent to the house of delegates by the clerk.

The bill entitled, a supplement to the act entitled, an act to establish a bank in the city of Baltimore, to be called the City Bank of Baltimore, was read the second time, passed, and sent to the house of delegates by the clerk.

The bill entitled, an act relating to the several banks within this state, was read the second time, and will pass with the proposed amendment, sent to the house of delegates by the clerk.

Amendment proposed.

After the word "money" in the eighth line of the bill insert, "not exceeding the amount of the capital actually paid in."

The bill entitled, an act relative to cases in the court of appeals, was read the second time, passed, and sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill entitled, an act for the relief of Elizabeth Reid, of Frederick county. A bill entitled, an act to authorise the transcribing of certain land records of Harford county court, and a bill entitled, an act relative to the unfinished records of Frederick county, severally passed by that house on the 14th January, 1815. Which were severally read the first time and ordered to lie on the table.

On motion by Mr. Hebb, leave given to bring in a bill entitled, an act to authorise and empower the levy courts of the several counties of this state to lay out or cause to be laid out, public roads in their respective counties. Ordered, that Mr. Hebb, Mr. Brown and Mr. Fenwick be a committee to prepare and bring in the same.

The bill entitled, a supplement to the act entitled, an act to incorporate a company for the purpose of building a bridge over the river Susquehanna, near Rock run was read the second time, and will pass with the proposed amendment, sent to the house of delegates by the clerk.

Amendment proposed.

Strike out the words "if required by the board of directors" in the interlineation between the second and third lines of the twelfth page.

On motion. Resolved, that the bill entitled, a supplement to the act passed at December session eighteen hundred and thirteen, chapter one hundred and eighteen, entitled, an act to prohibit the collection of certain wharsages within the city of Baltimore, have a second reading on Wednesday the 18th instant.

The senate adjourns until Monday morning 9 o'clock.

MONDAY, January 16:

The Senate met. Present the same members as on Saturday. The proceedings of Saturday, were read.

The bill entitled, an act for the benefit of the heirs of George N. Ford, late of Charles county, deceased, was read the second time, passed and sent to the house of delegates by the clerk.

The bill entitled, an act relative to the unfinished records of Frederick county, was read the second time, passed and sent to the house of delegates by the clerk.

The bill entitled, an act to establish a bank and incorporate a company, under the name of the Havre de Grace Bank, was read the second time, and will pass with the proposed amendments; sent to the house of delegates by the clerk.

Amendments proposed.

1st. Strike out the word "Henry" in the first line of the third page, and insert the word "Zebulon."

2d. Strike out from the word "but" in the eleventh line of the seventh page to the word "if" in the thirteenth line of the same page.

3d. After the word "state" in the first line of the nineteenth page insert the words "having jurisdiction thereof."

4th. After the word "dollars" in the twelfth line of the twenty-second page, insert the words "or such sum as now is or may be allowed by law."

5th. Strike out the words "at the discretion of the directors thereof" in the fourteenth line of the twenty-eighth page.

6th. Strike out the word "five" and insert the word "four" in the fifteenth line of the same page.

The resolution in favor of John Murray and Josias Stevenson, was read the second time, assented to and sent to the house of delegates by the clerk.

The bill entitled, an act for the relief of Elizabeth Reid, of Frederick county, was read the second time, and will pass with the proposed amendment; sent to the house of delegates by the clerk.

Amendment proposed.

At the end of the bill add "provided nevertheless, that the said Elizabeth Reid shall become a naturalized citizen of the United States, so soon as the same can be effected according to the laws thereof."

The bill entitled, a supplement to an act entitled, "an act for the benefit of certain persons who emigrated into or settled in this state before the adoption of the constitution of the United States," was read the second time, and will pass.

On motion the question was put, that the title be stricken out, for the purpose of inserting the following, to wit: "An act for the benefit of persons who have emigrated into this state since the adoption of the constitution of the United States." Resolved in the affirmative, and sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill entitled, a supplement to an act entitled, an act to incorporate certain persons in every Christian Church or Congregation in this state, passed at November session 1802. A bill entitled, an act to authorise and empower the justices of the levy court of Caroline county, to discontinue so much of the public road as is therein mentioned. A
