There are now under continuance on the docket of August term 1822 as follow; on the trial docket 105 suits, on the reference docket 67 suits, on the law docket two suits, on the equity docket 61 suits, and on the appeal docket 4 suits. At March term 1820 there were on the trial docket 65 judgments, (7 of which on verdicts) two were originated at August term 1816, two at August term 1817, one at March term 1818, 5 at August term eighteen hundred and eighteen, and 55 at March term eighteen hundred and nineteen. On the reference docket one judgment which was originated at August term eighteen hundred and eighteen. On the appeal docket two judgments which were brought up at August term eighteen hundred and nineteen. In this court no particular portion of the term has been appropriated to the trial of criminal cases, the court tho generally give that description of business the preference when the state and the accused are ready; the first Friday in each term has been set apart to hear appeals from the judgments of Magistrates; within the above recited period, there have been two adjourned courts to days beyond the regular terms, where a juror had been retained, one at August term 1820 to the 3d Monday of November, the other at March term eighteen hundred and twenty-one to the 1st Monday of May. The hours fixed for the sitting of the court have been from nine o'clock A. M. to 3 o'clock M. P. Which is submitted.
